1. Overview

The excel utility can be used for creating the XBRL/XML file for e-filing of shareholding pattern.

Shareholding pattern XBRL filing consists of two processes. Firstly generation of XBRL/XML file of the Shareholding pattern, and upload of generated XBRL/XML file to BSE Listing Center.

2. Before you begin

1. The version of Microsoft Excel in your system should be Microsoft Office Excel 2007 and above.
2. The system should have a file compression software to unzip excel utility file.
3. Make sure that you have downloaded the latest Excel Utility from BSE Website to your local system.
4. Make sure that you have downloaded the Chrome Browser to view report generated from Excel utility
5. Please enable the Macros (if disabled) as per instructions given in manual, so that all the functionalities of Excel Utility works fine. Please first go through Enable Macro - Manual attached with zip file.

4. Import XBRL file

1. Now you can import and view previously generated XBRL files by clicking Import XBRL button on General information sheet.

5. Steps for Filing Shareholding Pattern

I. Fill up the data: Navigate to each field of every section in the sheet to provide applicable data in correct format. (Formats will get reflected while filling data.)
- Use paste special command to paste data from other sheet.

II. Validating Sheets: Click on the "Validate " button to ensure that the sheet has been properly filled and also data has been furnished in proper format. If there are some errors on the sheet, excel utility will prompt you about the same.

III. Validate All Sheets: Click on the "Home" button. And then click on "Validate All Sheet" button to ensure that all sheets has been properly filled and validated successfully. If there are some errors on the sheet, excel utility will prompt you about the same and stop validation at the same time. After correction, once again follow the same procedure to validate all sheets.

Excel Utility will not allow you to generate XBRL/XML until you rectify all errors.

IV. Generate XML : Excel Utility will not allow you to generate XBRL/XML unless successful validation of all sheet is completed. Now click on 'Generate XML' to generate XBRL/XML file.
- Save the XBRL/XML file in your desired folder in local system.

V. Generate Report : Excel Utility will allow you to generate Report. Now click on 'Generate Report' to generate html report.
- Save the HTML Report file in your desired folder in local system.
- To view HTML Report open "Chrome Web Browser" .
- To print report in PDF Format, Click on print button and save as PDF.

VI. Upload XML file to BSE Listing Center: For uploading the XBRL/XML file generated through Utility, login to BSE Listing Center and upload generated xml file. On Upload screen provide the required information and browse to select XML file and submit the XML.

6. Fill up the Shareholding Pattern

1. Cells with red fonts indicate mandatory fields.
2. If mandatory field is left empty, then Utility will not allow you to proceed further for generating XML.
3. You are not allowed to enter data in the Grey Cells.
4. If fields are not applicable to your company then leave it blank. Do not insert Zero unless it is a mandatory field.
5. Data provided must be in correct format, otherwise Utility will not allow you to proceed further for generating XML.
6. Adding new rows: Sections such as Promoters details allow you to enter as much data in a tabular form. You can Click on "Add" to add more rows.
7. Deleting rows: Rows that has been added can be removed by clicking the button "Delete". A popup will ask you to provide the range of rows you want to delete.
8. Select data from "Dropdown list" wherever applicable.
9. Adding Notes: Click on "Add Notes" button to add notes

Disclosure notes of shareholding pattern:

It is hereby inform you that on the basis of intimation received from Aakaish Investments Private Limited (Transferee Company/Resulting Company) (one of the Promoter Group Company), received on Monday, November 07, 2022, the composite scheme of merger and arrangement ("**Scheme**") consisting demerger of Demerged Undertakings of Emtici Engineering Limited, Akaaish Mechatronics Limited, Wizard Fincap Limited, Speciality Wood Pack Private Limited, Prayas Engineering Limited, Elecon Information Technology Limited and Elecon Peripherals Limited (collectively referred to as "**Demerged Companies**"); and merger of Devkishan Investments Private Limited and Bipra Investments and Trusts Private Limited (collectively referred to as "**Transferor Companies**") into/with Aakaish Investments Private Limited (collectively referred to as "**Resulting Company**" or "**Transferee Company**") is approved by the National Company Law Tribunal, Ahmedabad Bench vide by an order dated November 02, 2022 (certified copy of said Order dated November 04, 2022) in accordance with Sections 230 to 232 and other applicable provisions of the Companies Act, 2013.

Upon the Scheme becoming effective based on the conditions as mentioned in the Scheme, all assets and liabilities of the Demerged Undertakings of the respective Demerged Companies and all assets and liabilities of the Transferor Companies will be transferred to and vested with the Resulting Company / Transferee Company being Aakaish Investments Private Limited. Pursuant to such transfers, the shareholding of Eimco Elecon (India) Limited held by Demerged Companies and Transferor Companies aggregating to 24.91% will be transferred to Aakaish Investments Private Limited (Resulting Company / Transferee Company).

The Demerged Companies except Wizard Fincap Limited, Speciality Wood Pack Private Limited and Elecon Peripherals Limited, Transferor Companies and Resulting Company / Transferee Company are disclosed as Promoter Group of the Company.

It is to be noted that there is no existence of Devkishan Investments Private Limited and Bipra Investments and Trusts Private Limited as on 31st December, 2022. Hence, from the next quarter i.e. on 31st March, 2023 and onwards the Company will not be showing these two Companies i.e. (1) Devkishan Investments Private Limited and (2) Bipra Investments and Trusts Private Limited in the list of PROMOTER GROUP Companies.

Please note that the aggregate holding of the promoter and promoter group in the Company, either in number or percentage, before and after the scheme, will remain same i.e. 74.06%.
